ADULT SPORTS CODE OF CONDUCT

The primary purpose of an adult sports program is to offer each resident of our community to pursue, through competitive sports, the physical and emotional benefits such activity offers. All too often the emphasis in such participation has been placed on winning at any cost. Good sportsmanship is expected and must be maintained at all times. It should be remembered that in every competitive sports activity there are winners and losers. The purpose of the Code of Conduct, is to engender and motivate a return to good sportsmanship, proper conduct on and off the field/court, and fully complying with the rules and policies of Santaquin Recreation. Effective immediately, the Code of Conduct, as defined below, is in force. All participants will carefully review the rules and requirements and are solely responsible for actions both on and off the playing field. Improper behavior on the part of any participant can directly affect the future participation of the entire team. The Participant's Code of Conduct applies to all players, coaches, and managers. This code applies to players as individuals or as a team, and the penalties can be applied to any individual or an entire team. This code becomes effective as soon as the participants arrive at the facility of play and remains in effect until the participants leave the facility.

* No Participant shall:

- A. At any time lay hand upon, push, shove, strike or threaten to strike an official, employee, or other participant.
- B. Endanger the safety of any player, official, employee or spectator.
- C. Refuse to abide by an official's decision.
- D. Use personal or verbal abuse upon any official for any real or imaginary wrong decision or judgment.
- E. Use unnecessary rough tactics in the play of the game against an opposing player.
- F. Demonstrate objectionable behavior or dissent at an official's decision by throwing equipment or any other forceful action.
- G. Discuss with an official in any manner the decision reached by such official (except Manager).
- H. Smoking while going on or coming off the facility, or while on the field of play.
- I. Discuss publicly with spectators in a derogatory manner any play, decision, or personal opinion of other players during the game.
- J. Appear on/at the facility in an intoxicated condition.
- K. Play under another individual's name, falsify name, or falsify address on an official roster.
- L. Play on more than one team in the same league.

** Not following Code of Conduct will result in penalties such as; warning by official, ejections, suspension from games or possibly the League.

*** All players must complete the roster and sign the waiver prior to participation or be subject to game forfeiture or disqualification. Note: We are requesting officials, umpires, City Employees, spectators or participants report any participant or team that refuses to abide by our established code of conduct. We are committed in making our leagues the best they can be. Particular attention will be made to player conduct.

I agree to abide by all rules and regulations governing adult sports, which includes any disciplinary measures, fines or suspensions levied by Santaquin Recreation.
