# A RESOLUTION RATIFYING AN AGREEMENT WITH UTAH COUNTY FOR THE PURCHASE OF SPILLMAN TOUCH SOFTWARE TO SUPPORT DISPATCH SERVICES.

WHEREAS, An Agreement was made and executed between Utah County, a political subdivision of the State of Utah, and Santaquin City, along with the Cities of Provo, Lehi, American Fork, Spanish Fork, Pleasant Grove, Springville, Saratoga Springs, Lindon, Nephi, Salem, and Mapleton, Lone Peak Police Department (Alpine/Highland) Juab County, Brigham Young University and Utah Valley University, hereby collectively referred to as the Parties, for the purchase of the Spillman Touch Software Feature for the Spillman Report Writing Program in support Dispatch Services; and

**NOW THEREFORE,** be it resolved by the City Council of Santaquin City the ratification of the agreement with Utah County for the purchase of the Spillman Touch feature to the Spillman report writing program currently utilized by the Parties; Santaquin City's portion representing \$981.77 with maintenance of \$134.62.

#### **AGREEMENT**

Agreement made, and executed, by and between Utah County, a political subdivision of the State of Utah, PROVO CITY, LEHI CITY, AMERICAN FORK CITY, SPANISH FORK CITY, BRIGHAM YOUNG UNIVERSITY, PLEASANT GROVE CITY, SPRINGVILLE CITY, SARATOGA SPRINGS CITY (and Bluffdale), LONE PEAK POLICE DEPARTMENT (Alpine/Highland), LINDON CITY, SANTAQUIN CITY, JUAB COUNTY, NEPHI CITY, SALEM CITY, UTAH VALLEY UNIVERSITY and MAPLETON CITY, located in Utah and Juab Counties, hereinafter collectively referred to as the Parties.

WHEREAS, the Parties to this Agreement desire to add the Spillman Touch feature to the Spillman report writing program currently utilized by the Parties; and

WHEREAS, the Parties will receive substantial savings by purchasing the Spillman Touch module as a group;

NOW THEREFORE, in consideration of the mutual agreements of the Parties, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. Utah County will enter into the attached Quote and Purchase Addendum with Spillman to license the Spillman Touch feature for the Parties' Spillman report writing programs and pay the license fee therefore.
- 2. The Parties will pay Utah County their proportionate cost of the Spillman Touch license in the amounts and at the times indicated in the attached chart.
- 3. Spillman will separately bill each Party, and the Party will pay Spillman directly for ongoing maintenance fees.
- 4. This Agreement may be executed in two or more counterparts, all of which together shall be considered one agreement. This Agreement will be effective as to each signing party.
