## **RESOLUTION No. 01-06-2014**

## A RESOLUTION OF THE SANTAQUIN CITY COUNCIL AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH VERIZON WIRELESS AUTHORIZING THE TEMPORARY USE OF CITY OWNED PROPERTY LOCATED AT 200 SOUTH 400WEST.

WHEREAS, the City of Santaquin is interested in providing additional communications facilities within the City limits, which are necessary for the public health, safety, and welfare of residents, businesses owners, visitors, and public safety personnel; and

WHEREAS, the City of Santaquin and Verizon Wireless (VAW) LLC d/b/a Verizon Wireless ("Verizon Wireless") desire to coordinate efforts regarding a potential telecommunications site on City owned property located at 200 South 400 West (Property); and

WHEREAS, Santaquin desires now to provide a 180 day right-of-entry on the Property to Verizon Wireless;

## NOW THEREFORE, BE IT RESOLVED BY THE SANTAQUIN CITY COUNCIL THAT:

- 1. The Santaquin City Council approves and authorizes the Mayor to execute that document granting a Right-of-Entry to Verizon Wireless, a copy of which document is attached hereto as Exhibit A and incorporated herein.
- 2. The Right-of-Entry is approved with the condition that Verizon Wireless restore all parts of the Property which they may damage or disturb during their site inspections, surveys, analysis, testing, etc. to the state in which it currently exists, or better, within 10 days of the completion of their activities to determine suitability of the site for their desired telecommunications facilities or the termination of the right-of-entry, whichever is earlier.
- 3. This resolution shall take effect on January 16, 2014.

## RIGHT OF ENTRY

Authority. The individual executing this consent on behalf of the Owner represents to Verizon Wireless that such individual is authorized to do so by requisite action of the Owner.
