WHEREAS, the City of Santaquin has an inventory of evidence associated from various Police Department Cases, and


WHEREAS, this property is of no use to any department of Santaquin City, and

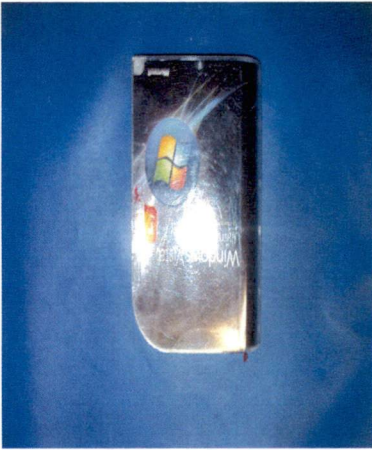

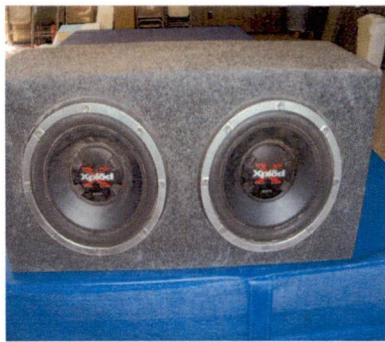
