A RESOLUTION OF THE SANTAQUIN CITY COUNCIL APPROVING AN AGREEMENT WITH THE UTAH DEPARTMENT OF TRANSPORTATION (UDOT) REGARDING THE PARK AND RIDE AT THE CORNER OF SR198 AND US-6 MAIN STREET

WHEREAS, UDOT provides property along SR198 and US-6 for use as a park and ride facility; and

WHEREAS, said facility is occupied by a substantial number of vehicles for sale which has limited the space for the commuting public; and

WHEREAS, UDOT does not have an enforcement arm and works with its local government partners for enforcement of its park and ride facilities; and

WHEREAS, the City of Santaquin and UDOT desire to coordinate efforts regarding the maintenance of the park and ride; and


WHEREAS, the Utah Interlocal Cooperation Act, Utah Code Ann. §11-13-1 et seq., authorizes political subdivisions of the state to enter into agreements in order to cooperate in providing services; and

NOW THEREFORE, BE IT RESOLVED BY THE SANTAQUIN CITY COUNCIL THAT:


1. The Santaquin City Council approves and authorizes the Mayor to execute the Park and Ride Agreement between Santaquin City and UDOT, a copy of which is attached hereto as Exhibit A and incorporated herein.

AGREEMENT

THIS AGREEMENT, made and entered into this 29 day of NOV, 2016, by and between the **UTAH DEPARTMENT OF TRANSPORTATION**, hereinafter referred to as "**UDOT**", and **SANTAQUIN CITY CORPORATION**, a Municipal Corporation of the State of Utah, hereinafter referred to as the "**CITY**",

WITNESSETH:

WHEREAS, there is **UDOT** property currently being used as a park and ride lot located in Santaquin on SR-198 near I-15 and adjacent to a Maverick gas station; and

WHEREAS, **UDOT** desires to have **CITY** now take over maintenance of the lot;

THIS AGREEMENT is made to set out the terms and conditions whereunder said work shall be performed.

NOW THEREFORE, it is agreed by and between the parties hereto as follows:

1. The **CITY** agrees to provide police protection, remove snow, grade and maintain said lot in a manner satisfactory for a suitable parking area to a level of service approved by the **CITY**.
2. **UDOT** will remain the owner of the real property.
3. Location prints showing said park and ride lot are marked "**EXHIBIT A**" and attached hereto and there by made a part hereof.

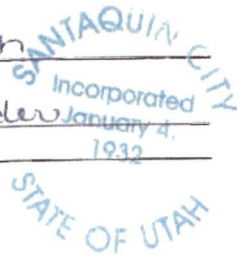
